EFFECTIVE DATE: July 1, 2016. Federal Grain Inspection Service (F.G.I.S.) must approve all fees for official services. Official agencies will assess only those fees appearing on their current approved fee schedule.

OFFICE HOURS: Regular hourly rates are from 8:00 am to 4:30 pm, Monday through Friday EXCEPT holidays.

BILLING METHOD: Hourly rates for sampling, inspecting and weighing will be charged in quarter hour increments, per individual, in addition to unit fees.
Holidays include all holidays as recognized by the U.S. Government.

DOWNTIME: Downtime will be assessed at the applicable hourly rate.

MILEAGE RATE: The IRS Standard Mileage Rate will be assessed for all services performed basis portal to portal, rounded down to the lower cents. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage will be prorated when more than one elevator per trip. Mileage will be assessed for each vehicle. More than one vehicle may be necessary for an elevator with on-site inspection lab.

ON-SITE LAB STAFFING: Travel time will be assessed at applicable hourly rate and require a minimum of two individuals. Travel is depart/arrive Sandusky Office, plus miles, travel time and inspection fees. On-site lab inspection personnel are available on a "first come, first serve" basis. If D.G.I.S. does not have inspectors available to serve at an on-site lab, a sampler would be provided at the lab and the sample(s) inspected as soon as possible. There is a minimum call out charge of two (2) hours during regular business hours or four (4) hours outside of regular business hours at applicable hourly rate.

LODGING: Actual expenses are assessed per person when overnight lodging is required.

Probe samples will be assessed the applicable hourly rate when service is requested during non-business hours or sampling is on standby waiting for completion of loading.	
<u>Mechanical Sample</u> , per carrier (all carriers) plus applicable hourly rate-----	\$19.40
<u>Submitted Sample</u> , per sample for grade-----	\$16.50
Submitted samples will be assessed the applicable hourly rate when service is requested during non-business days. (Monday-Friday, except Holidays)	
<u>Vomitoxin/Aflatoxin</u> per test, after grading-----	\$28.00
<u>Vomitoxin/Aflatoxin</u> per test without grade or submitted-----	\$30.00
<u>Reinspection</u> , based on file sample-----	\$16.00
<u>Reinspection</u> , based on new sample-----	same as original sample
<u>Additional Factors</u> , per factor (i.e. sprout damage, BCFM breakdown, etc.)-----	\$5.00
<u>Additional Statements</u> on certificates, per statement-----	\$2.50
<u>Stowage Examinations Only</u> , per unit (Plus applicable hourly rate)-----	\$3.00
<u>Check Testing</u> mechanical samplers and lab equipment will be assessed at the applicable hourly rate plus mileage and travel time.	
<u>On-Site Lab Supplies</u> (light bulbs, dust filters, etc.) will be assessed at actual cost.	
<u>Sealing Railcars</u> , 2 seal/car – no charge, Seal All Latches-----	\$1.50
<u>Fax Fee</u> , per page-----	\$1.50
<u>Postage, UPS, Fed Ex</u> expenses will be assessed at actual cost.	
<u>Class X weights</u> , per truck/container, plus applicable hourly rate-----	\$3.00
