Effective Date: **July 1, 2016**

The Federal Grain Inspection Service (FGIS) must approve all fees for official services and all Official Agencies will assess only those fees appearing in their current approved fee schedule.

Regular Hours – All Locations

0700 Hours to 1500 Hours Monday through Friday, except Holidays

Overtime Hours – All Locations

Saturday and all other weekly hours, other than regular hours, shall be considered overtime. For services performed outside of regular hours overtime rates shall be applicable.

Double Time Hours – All Locations

Sunday and all Holidays

Call Out Hours – All Locations

A minimum of 4 hours will be assessed at the applicable hourly rate when requests for services are withdrawn or in the event that the request results in personnel returning to duty after dismissal.

Standby Rates

Standby Rates will be assessed at the applicable hourly rates for delays not caused by the Agency. Hourly rates are assessed in addition to unit fees in quarter-hour increments for work performed outside of office(s).

Overtime Mechanical Truck Sampling and Inspection Assessment

A minimum of 15 trucks per hour will be assessed for all requested overtime hours.

Mileage Rate

The IRS standard rate will be assessed for all services on a portal to portal basis. Any change to the mileage rate will become effective when the IRS standard rate changes. Mileage will be prorated when possible.

Official Commercial Inspection Services are offered and will be negotiated on a case by case basis from our officially approved fee schedule.

High Volume contract for Container loaders
All containers represent a monthly basis:

1. The first 500 containers of bulk grain will be billed at \$27.50 per container and guarantees a minimum of 500 containers per month.
2. Containers from #501-1000 will be billed at a rate of \$26.25 per container.
3. Containers from #1001-1500 will be billed at a rate of \$25.25 per container.
4. Containers from #1501 and above will be billed at a rate of \$24.25 per container.

There will be no charge for man-hours or weighing under this high volume container contract.

Customers who elect to use the high volume container contract must commit to it for at least three (3) consecutive months.

Items that are considered extra charges will be billed according to Mid Iowa Grain approved USGSA fee schedule include but are not limited to:

1. Administrative fees for changing original certificates after being completed billed in quarter hour increments at the Sampler hourly rate.
2. Courier fees: A mark up of 10% if shipped on MIG's FedEx account.
