OFFICIAL AGENCY FEE SCHEDULE

EFFECTIVE DATE: July 1, 2016. This fee schedule supersedes all other fee schedules established by this agency. The Federal Grain Inspection Service must approve all fees for official services, and Official Agencies will assess only those fees appearing on their current approved fee schedule.

HOURLY RATES: Regular Time: \$25.00 Overtime: \$37.50 Travel Time: \$25.00

Regular hours are assessed in ¼ hour increments, Monday-Friday, 8:00 AM to 12:00 noon, 1:00 PM to 5:00 PM. Regular hours may be established to meet local industry hours, not to exceed 8 hours per day. Weekends, holidays, and all other hours will be considered overtime.

MILEAGE RATE: Vehicle mileage will be assessed at the prevailing state rate. Mileage assessment will be prorated when more than one request per dispatch is service.

HOLIDAYS: All holidays designated by the Governor of The State of South Carolina.

TRAVEL TIME: Assessed per individual dispatched, at regular –hourly rate only.
