Some states **require** a State agency or official be named as trustee. Those states with that requirement are listed in the next section of this form.

The *UNITED STATES DEPARTMENT OF AGRICULTURE*, or *THE PACKERS AND STOCKYARDS PROGRAM*, does not act in the capacity of a Trustee or Obligee and should not be named in either position.
